SUPERINTENDENT’S REPORT

Resolution to Adopt Tabulation of Votes Cast at Annual District Meeting - Mrs. Waldron made a motion seconded by Mrs. Knox that upon recommendation of the Superintendent of Schools, be it RESOLVED, that WHEREAS, the Annual Election of the Qualified voters of the Smithtown Central School District was duly held and conducted this day; and
